Any comments on the financial status (e.g., significant deviations from the original budget allocations, over/under-expenditures): In general, the budget execution for the whole project is high and very rewarding, two over expenditures especially on Advocacy/Outreach and on Fellowship and grants were due to budgeting underestimation and this was compensated by a prior request for budget reallocation that has been done for three activities that are Human resource and Development of joint action between UPHLS and services providers and Engagement of the social welfare sub/committee of the Parliament that shifted and contributed respectively to study tour and 5 Year Strategic planning of UPHLS and DPOs coalition (This has been communicated to UNDEF).

3. MANAGEMENT ACTIONS

Recruitment of Staff: In the first year of the project implementation there was no staff recruitment and top up allowance was given to 14 staff that was supporting the project. Ten staff used to get 8% each as top up, the total for all monthly top up in this category was USD\$1,040 and 4 Administrative staff used to get 5% each as top up! The total for monthly top up in this category was USD\$ 120. Overall monthly total for top up category was USD\$1,160. In the second year of the project, UPHLS was in the process of downsizing due to phase out of the SSF project «Scaling up Access to HIV&AIDS services with Focus on Prevention in Rwanda» (funded by the Global Fund) that was supporting the biggest percentage of staff salaries, however the UNDEF project remained functional with a recruitment of a full time paid project officer and his assistant to implement the UNDEF project. (This has been communicated and approved by UNDEF)

Procurement of Equipment: There was a purchase of project equipment that included a project laptop and a digital camera.

Partnership Agreements: UPHLS already had partnership agreement with Disabled People Organizations (DPOs) to contribute in the project implementation. There were also involvement in the project steeering committee of the Ministry of Health (Rwanda Biomedical Center) and Handicap International as an international NGO.

Set up of Monitoring or Steering Committees: A steering committee was set up to monitor the implementation of the project. The committee was made by 8 persons from National Union of Disabilities' organizations of Rwanda (NUDOR), National Council of Persons with Disabilities (NCPD), Handicap International (HI – Program Rwanda), Rwanda Biomedical Center (RBC), Rwanda National Union of the Deaf (RNUD), Association Générale des Handicapées au Rwanda (AGHR), Rwanda Union of the Blind (RUB) and UPHLS



Other Management Actions: UPHLS coordinated and monitored the implementation of project activities. The main actions involved here are:

- Routine monitoring of project implementation;
- Development of various Terms of References prior to implementation of each project activities;
- Coordination and financial management of project implementation;
- Steering committee made up of UPHLS management, Project staff and representative of implementing partners met on a quarterly basis for overseeing the proper implementation of the project and advise in aspects of planning, overall coordination, monitoring, review and advocacy;
- Project reporting;

There was delay in implementation of advocacy strategy, radio talk shows, public debate and some outreach campaign due mainly to the following factors:

- Lack of self-esteem among persons with disabilities (PWDs) to advocate for their own cause due to limited skills in advocacy and availability of local authorities;
- Administrative procedures and bureaucracy in public institutions and local government institutions.
- Limited budget for some activities;
- In the second year of the project, a downsizing of staff occurred due to phasing out of SSF project as mentioned above under "Other management actions".

Two budget reallocations occurred during project implementation:

- Budget balance from Human resource was relocated to study tour to support additional persons (two persons were added as personal assistants of persons with disabilities in the team and one sign language interpreter).
- Budget for the development of joint action plan between UPHLS and services providers and Engagement of the social welfare sub/committee of the Parliament reallocated to the development of the 5 Year Strategic plan for a coalition made by UPHLS and Disabled People Organizations.

- Annual partnership review from year one to the end of year two
- Sharing learning through study tour was scheduled to be conducted in Uganda but later shifted to Kenya (This has been communicated and approved by UNDEF)

The mapping of health and rehabilitation services for persons with disabilities in Rwanda was conducted in 2014 and together with the Baseline survey on social inclusion of Persons with Disabilities into Social services conducted in 2012; it provided proper guidelines to carry out our effective advocacy on health inclusion for persons with disabilities. Intended 1.1.1: Two training lasting 2 days for PWDs groups' representatives on leadership, governance and UNCRPD;

Actual: Training of PWDs groups' representatives on leadership, governance and UNCRPD has been conducted. The 1st training was conducted with 30 participants from 17 to 18 November 2014 at Centre Saint André Kabgayi in Muhanga District and the 2nd training was also conducted with 30 participants from 19 to 20 November 2014 at Hotel Saint Agnes in Rwamagana District with main objectives to strengthen and sustain DPOs through the empowerment of group leaders (PWDs) in the management of their grass root associations in areas of leadership and good governance; and to equip PWDs with necessary tools / rights to support their advocacy interventions through the empowerment of PWDs group leaders on the United Nations Convention on the Right of Persons with Disabilities (UNCRPD)

Intended 1.1.2:One training lasting five days for youth with disabilities on self-advocacy, CBR & gender equality

Actual: The training of youth with disabilities on self-advocacy, CBR & Gender equality has been conducted with 30 participants. The training was conducted from 22-24 April 2015 at St Andre Kabgayi in Muhanga District with the main objective of strengthening their knowledge to make great self-advocacy, Community Based Rehabilitation, gender equality and how to integrate PWDs in the society.


Intended 1.1.3: One training lasting five days for women with disabilities on self-advocacy, CBR & gender equality

Actual: The training of women with disabilities on self-advocacy, CBR & Gender equality has been conducted with 30 participants. The training conducted from 29th April-01st May 2015 in Centre St Agnes Rwamagana District with the main objective strengthens their knowledge on Advocacy strategy, Community Based Rehabilitation, gender equality and gender equality.

The training conducted from 15th22nd March2016 at Centre St Andre Kabgayi in Muhanga District with the main objective to equip them with knowledge on disability historical background / situation, disability equality, disability mainstreaming, disability legal framework.

In details: 9 self-help groups of PWDs in City of Kigali and 9 per each of the four Provinces of Rwanda (That gives a total of 36 self-help groups of PWDs). Based on the need, UPHLS supported 15 self-help groups of PWDs in having a constitution, 30 self-help groups of PWDs in developing strategic / business Plan and 30self-help groups of PWDs have been supported for the establishment and inclusion of youth and women in governing committees

Intended: **Output 2.1**: 30 Community-based consultation meetings held.

Intended 2.1: UPHLS had to organize 30 consultation meetings with 25 key stakeholders (government, civil society and DPOs) each, using a community-based approach during the 1st quarter of the project.

Actual: 23 Community based consultation meetings have been conducted

Actual: Community based consultation meetings consisted of the introduction of the UPHLS/UNDEF project at community level. The activity was with an approximate number of 25 participants each and conducted from May 2015 in 23 Districts of Rwanda. These meetings served as preparatory meetings of outreach campaigns and awareness creation on the project objectives and captured views and recommendations. The meetings targeted the involvement of community members and local leaders in project.

Intended: **Output 2.2**: 4 regional consultations between PWDs and government officials held

Intended 2.2: The Steering Committee had to organize regional consultations in each province involving: Governor, Vice Mayors in charge of Social affairs, Chair of the Districts Joint Action Development Forum, District Health committee representative and representatives of DPOs) in each of the four regions of Rwanda. This activity was to be carried out during the 1st quarter of the project.

Actual: 4 regional consultations between PWDs and government officials have been conducted

Actual: The Steering Committee has organized 4 regional consultations in each province involving: Governor or his representative, Vice Mayors in charge of Social affairs, Chair of the Districts Joint Action Development Forum, District Health committee representative and representatives of DPOs and members of the Project Steering committee in each of the four regions of Rwanda to create awareness on the project objectives and capture views on this project to readjust if necessary (Reports of the meetings are attached).

These meetings had an approximate number of 32 participants each and targeted to raise the awareness on the project objectives, capture views on the project as well as the involvement of local authorities and PWDs leaders in the project. The Regional meetings have been conducted as follows:

- Regional consultation meeting Southern Province: 11 November 2014
- Regional consultation meeting Northern Province: 29 October 2014
- Regional consultation meeting Eastern Province: 7 November 2014
- Regional consultation meeting Western Province: 30 October 2014

Intended2.4: Ten public debates involving community leaders, local authorities, self-help groups' leaders, DPO's and decision makers will be held at National and District level and aired on radio to raise awareness of the population on disability issues and support the advocacy towards the

amendment of social and health policies to be more inclusive of persons with disabilities.

Actual: 10 public debates have been conducted from May 2015 in different sectors of Rwanda. Public debates have been conducted with around 13 participants involving Sector executive secretary or his representative, In charge of social affairs, Chair of Joint Action Development forum, Nurse in charge of community health workers, one person in charge of cooperative in the sector, One person in charge of education, one person from the national council of women, one person from the national council of youth, one person from national council of person with disabilities, one person from NUDOR and 3 representative of cooperative. The debate had the target to raise awareness of the population on disability issues and support the advocacy towards the amendment of social and health policies to be more inclusive to person with disabilities.

Intended: **Output 3.1**: Three advocacy conferences and eight outreach campaigns per District to fight against stigma and promote disability equality are conducted

Intended 3.1.2. Celebration of the international disability day

Actual A preparatory meeting involving members of the project steering committee was held to organize the event in 2014 and 2015;

In 2014 the International Day of Persons with Disabilities has been celebrated officially on December 3rd, 2014 in Karongi District of the Western Province where UPHLS was advocating through the exhibition of tools used for the inclusion of Persons with Disabilities in Health and Social Services. Another celebration was held in Kicukiro District of Kigali City at the same date with exhibition and speech on the inclusion of Persons with Disabilities in Health and Social Services. The celebration was conducted with the theme on ICT which was aligned with both the international and national themes that are inclusive of ICT. The media covered the event. (Report attached for more details)

In 2015 the International Day of Persons with Disabilities has been celebrated officially on December 3rd, 2015 in Musanze District of the Northern Province where UPHLS was advocating through the exhibition of tools used for the inclusion of Persons with Disabilities in Health and Social Services. Other celebration was held in Gicumbi District in the Northern province and Nyaruguru District in the southern province at the same date with exhibition and speech on the inclusion of Persons with Disabilities in Health and Social Services. The celebration was conducted with the theme "Inclusion matters:



access and empowerment for people of all abilities". The media covered the event. (Report attached for more details). Comments on achievements under Outcome 1: A local movement to support people with disabilities has been established, strengthened and coordinated where different actors have been trained and included in project lifespan (local authorities and decision makers, PWDs themselves, service providers, religious leaders, journalists, community leaders, etc.) but the coalition is still in its early stage. We cannot say that it is sustainable; this is mainly due to the fact that the project has not lasted long enough to allow the coalition to mature.

Outcome 2: Health policy framework is more inclusive of persons with disabilities

Comments on achievements under Outcome 2: The Health policy framework has not changed a lot since the start of the project and disability is not covered in comprehensive way. The project started to highlight some of the gaps in the policy and few actors are aware of the issues but still there is a need to increase awareness among key decision makers so the policy can be amended and made more inclusive of persons with disabilities.



Outcome 3: The advocacy to fight against stigma has increased

Target:3.1 At least one affirmative action per month from the speech of local authorities at opening, during or closing of ceremonies Results: Many affirmative actions have been captured almost in every speech of the guests of honor invited in ceremonies during the project lifespan. There were more than 10 affirmative actions per month during the project implementation. Examples of ceremonies and events where those actions were captured are:

- Regional consultation meetings;
- World AIDS Day (WAD);
- International day of persons with disabilities (IDPD);
- National Forum;
- Community consultation meetings;
- Outreach campaigns;
- Training workshops and meetings

Comments on Results: Here are some of the affirmative actions captured:

- WAD and IDPD were celebrated the same day in Rwamagana District, where Mr.
 UWIMANA Nehemiah / Mayor of Rwamagana District who focused and insisted on the fight against stigma and discrimination towards PWDs in the society and especially at community level;
- In the opening speech of the regional consultation meeting held in Rwamagana District, Mr. MAKOMBE Jean Marie Vianney representing the Governor of Eastern Province, requested local authorities and project partners for joint response toward stigma and discrimination faced by PWDs and promised that the Eastern Province will be always available to host UPHLS activities under this project as well as support in achievement of the recommendations that were given during the workshop.

Among recommendations from other workshops:

- Local authorities have a duty to educate everyone to respect the rights of persons with disabilities,
- Local government and DPOs should fight against stigma and discrimination faced by PWDs and bad culture of begging among PWDs so that they can work and participate in the development of the country
- One province agreed to advocate so that the Districts action plans and budget be more disability inclusive

Comments on Results:

- We still have gap in the number of female



participating at sit ball, goal ball and wheelchair volley ball tournaments at national, regional or international level respectively women and Sit-ball teams for men and women participating in different national tournaments. No tournament has been captured and monitored at regional or international level.

- teams in goal ball.
- For wheelchair volley ball there is a lack of expertise and coaching personnel in the sport.
- We have not been able to monitor the selection of players from the local teams to represent the country in tournaments at regional and international level due to limited timeframe for this project. But we are expecting this to happen in the near future.
